We recently published the Scottish versions of the Minor Works suite of contracts and the generic sub-contracts and will shortly publish the Design and Build and the Standard Building contract suites. Adapted from their JCT counterparts, these contracts are designed specifically for use in Scotland.

As the new editions include major changes, SBCC wants to give construction industry professionals the opportunity to learn in advance of using the contracts how these changes will affect them. We are therefore running a series of familiarisation seminars, initially in Glasgow and Dundee.

The seminars will provide invaluable information about the work of SBCC and enable delegates to familiarise themselves with the changes applicable to the three main suites of contracts.
